GENERAL TERMS AND CONDITIONS

FOR THE RENTAL OF MOBILE-HOMES AND CHALETs

1. The rental is a personal contract. It can not be transferred and subletting is not allowed. All registrations must be accompanied by a down-payment equal to 25% of the total amount of the stay.
2. The keys from the accommodation will be handed over between 5pm and 7pm or 8pm in high season (if late check-in is needed, please give us adequate warning). Departures are before 10am.

In high season, rental on a weekly basis only, from Saturday to Saturday (please check on price list)

3. Reservation is valid after written confirmation from the campsite following receipt of this agreement duly completed and signed, including the requested down payment. The balance is payable at least 4 weeks before your arrival on the campsite. If it is not paid by this deadline, your booking will be automatically cancelled.
4. Any cancellation must be notified in writing, the date of reception determining cancellation date.
In case of cancellation, will be charged:
 - insurance cost
 - as compensation for breach of contract:
 - an amount of 20% of the total cost of the stay, if we receive notice more than 30 days before the expected arrival date.
 - the total cost of the stay if you cancel less than 30 days before the expected arrival date, or if you do not show up by that date
5. No refunding will be made in case of delayed arrival or early departure. Only prior subscription to the cancellation insurance may allow you to obtain a refund, depending on the reason of the departure
6. CANCELLATION INSURANCE + HOLIDAY INTERRUPTION

The optional cancellation insurance, highly recommended, refunds the compensation for breach of contract, within the following guarantees: Death or temporary or permanent impediment of the participants or their families – Illness - Serious damage to your home - Your call up for an organ transplant - Serious damage to your vehicle - Pregnancy complications - An accident or break down of your means of transport - Redundancy - Job transfer - Being hired for a paid job or training course - A summons in court - A call for reset examination - vaccination contraindication - A call for a child adoption - A change of your leave dates on behalf of your employer - The theft of your identification papers. In case of cancellation, **inform the campsite** of the termination of your booking and **report the claim** within 5 working days, through <http://en.campez-couvert.com/declaration>.

7. On arrival, you will be asked for a **200 €** deposit for the mobile-home or chalet, which includes a guarantee for material breakage and cleanliness of the accommodation on your departure. It will be refunded at the end of your stay, with possible deduction made for the cost of missing/damaged items. Cleaning is the responsibility of the tenant. Except if you have paid for the optional “end of stay cleaning”, the mobile-home or chalet must be returned in perfect state of cleanliness. If not, a minimum sum of **70 €** will be withheld from the deposit.
8. A civil liability insurance is mandatory. Insurance certificate must be returned with the booking form. The management is not responsible in case of theft, loss, damage of any kind during or following your stay
9. Any litigation that may arise shall be dealt with exclusivity by Tribunal d’Instance des Sables d’Olonne. The French version of the agreement shall be regarded as the authentic text of the contract. Conforming to article L. 152-1 of the consumer code, you have free recourse to the MEDICYS mediation service where we can be reached via the website: <https://app.medicys.fr> or by post: MEDICYS - 73 Boulevard de Clichy - 75009 PARIS.
10. Residents must comply with the campsite rules at all times, especially those regarding night-time noise levels. Please note that car access in and out of site is not allowed from 10.30 pm to 7 am. Vehicles arriving after 10.30pm must park in the outer parking area. Copies of the Campsite rules and regulations are available at reception and will be sent on request.
