GENERAL CONDITIONS COVERING THE RESERVATION OF TENT OR CARAVAN PITCH

Castel Camping La Garangeoire accepts reservation of pitches in order to ensure that a place is available for the camper on the day of his arrival. This reservation is subject to the following conditions:

Application shall be accompanied by an amount of 125 € (+ the amount of rented equipment and the amount of the cancellation insurance if applicable) as a deposit, which will be deducted from the total due for the stay, plus 25 € to cover booking costs. The **150 €** should be transmitted by credit card or bank transfer. The balance for the stay is to be paid on arrival.

After receipt of your deposit and application forms duly completed and signed, we will send you a confirmation of booking.

DO NOT FORGET

1. The pitch is available from noon, except for PREMIUM and PRIVATE SANITARY pitches or the pitches with a refrigerator or furniture hire for which arrival time is 2pm. The pitch must be vacated by noon on the day of the departure.
2. The pitch may be occupied by 6 persons maximum (or by parents + children in case of large families)
3. The reservation is a personal contract: it cannot be transferred and subletting is not permitted.
4. Any modification of the details originally stated must be stated on arrival at the campsite. In event of inaccurate information having been given in the Agreement, this contract will be cancelled and the deposit already paid will not be refunded.
5. If your arrival is to be delayed we ask you to notify us, so that your pitch can be kept for you. If there has been no news from you after 24 hours from the stated date of your arrival, the Administration reserves the right to re-allocate the pitch. Should you cancel your reservation up to 30 days before your arrival date, your deposit will be refunded. If the notice of the cancellation is received later than 30 days before your arrival date, no refund is possible.
Under no circumstances can the 25 € booking fee be returned.
6. Once your stay has begun, no refund can be made for premature departure, whatever the reason. Consequently, **we strongly recommend subscribing the optional cancellation insurance.**
7. Any litigation that may arise shall be dealt with exclusivity by Tribunal d'Instance des Sables d'Olonne. The French version of the agreement shall be regarded as the authentic text of the contract.
8. Please return the agreement, duly completed and signed. A copy will be sent back to you, counter signed by the Administrator.
9. Rental of refrigerator and / or furniture must be paid at time of booking and payment is not refundable (unless taken into account by the insurance).

Conforming to article L. 152-1 of the consumer code, you have free recourse to the MEDICYS mediation service where we can be reached via the website: <https://app.medicys.fr> or by post: MEDICYS - 73 Boulevard de Clichy - 75009 PARIS

Residents must comply with the campsite rules at all times, especially those regarding night-time noise levels.

Access to the campsite is closed for vehicles from 10.30pm to 7am. Vehicles arriving after 10.30pm must park in the outer parking area. Copies of the Campsite rules and regulations are available at reception and will be sent on request.

These details are considered necessary in order to avoid any misunderstanding. We shall look upon you, as always, as our very welcome guests, and are confident that you will take away with you enjoyable memories of your holiday at **La Garangeoire**.

CANCELLATION INSURANCE + HOLIDAY INTERRUPTION

Any cancellation must be notified by a letter, the date of receipt determining the date of cancellation. The optional cancellation insurance, highly recommended, refunds the compensation for breach of contract, within the following guarantees: - Death or temporary or permanent impediment of the participants or their families – Illness (including Covid19 at time of departure, on presentation of a medical certificate) - Serious damage to your home - Your call up for an organ transplant - Serious damage to your vehicle - Pregnancy complications - An accident or break down of your means of transport - Redundancy - Job transfer - Being hired for a paid job or training course - A summons in court - A call for reset examination - A call for a child adoption - A change of your leave dates on behalf of your employer - The theft of your identification papers - Campsite concerned by a confinement or access prohibition measure justified by an administrative order for the period of stay.
